Section 4: First aid measures

4.1. Description of first aid measures

First aid for skin:

Remove contaminated clothing and wash immediately contact area with soap and water for 15 minutes. If irritation persists seek medical attention.

5.1. Extinguishing media:

Use carbon dioxide, dry chemical, aqueous foam. Do not use water stream.

5.3. Advice for fire-fighters:

Remove all ignition sources. Wear self-contained breathing apparatus and complete personal protective equipment when entering confined areas where potential for exposure to vapours or products of combustion exists. Do not allow run-off from fire fighting to enter drains or water courses.
